

Reference to your application to the Railway Recruitment Cell /SC, you are hereby offered appointment as Track
Maintainer-IV in Pay Matrix Level-I/[Pay Band-I Rs. 5200-20200/- + Grade Pay Rs. 1800/-] in Civil Engineering
Department on NED Division subject to the following terms and conditions.

1. You will receive a pay of Rs-18000/- per month in pay matrix Level-I/[PB-1 Rs. 5200-20200/- + Grade Pay Rs.
1800/-] plus allowances as admissible under the rules in force.

2. You will be on probation for a period of TWO years from the date of appointment.

3. Your appointment will be subjec. to all the rules and regulations issued by the Government of India and South
Central Railway administration from time to time.

4. Your appointment is terminable on 14 days notice on either side. No such notice is required if the termination of
service is due to the expiry of the sanction to the post, you hold or on return to duty of the absentee in whose
place you may be engaged in which case your service will be automatically terminated from the expiry of the
sanction or from the date of the absentee resumes duty as the case may be. Also no such notice will be required if
the termination of service is due to your mental or physical incapacity or due to your removal or dismissal as a
disciplinary measure after compliance with the provisions of clauses (2) of Article 311 of the Constitution of
India.

5. You must be prepared to serve at any station on NED Divn and you are liable to be posted anywhere and
transferred to any station on S.C.Railway.

6. You will be governed by liberalized leave rules contained in Railway Board's letter No E.47 GPC.118 of
09.03.1949 as amended from time to time.

7. You will be governed by the rules applicable from time to time to the staff of Indian Railway and governed by
new pension scheme implemented w.e.f.01.01.2004 onwards.

8. You must bring your original Educational Qualification, Date of Birth, Caste, Transfer Certificates etc for
verification and required to submit one set of attested copies of all the certificates duly attested by Gazetted
officer. If you belong to Scheduled Caste /Scheduled Tribe or OBC you should produce original Caste certificate

10. Your appointment is provisional and is subject to the SC/ST/OBC community certificate being verified through
